VILLAGE COUNCIL MEETING MINUTES

February 25, 2021 – 9am Village Hall, 10004 New Town Road Work Session – Virtual Meeting

A. AGENDA ITEMS

1. Call to Order

Mayor Pollino called the meeting to order at 9:04am and determined a quorum was present.

Present Virtually: Councilman Marcolese (disconnected 2:07pm, reconnected 2:09pm)

2. Consider Allowing Councilmembers to Participate Remotely

MOTION: Mayor Pro Tem Vandenberg moved to allow councilmembers to participate remotely.

VOTE: The motion passed unanimously.

3. Adoption of the Agenda

Mayor Pro Tem Vandenberg requested to make the following changes:

- Add Item #18 "Approve 2020 Tax Refunds as of February 23, 2021."
- Add Item #19 "Report of Total Unpaid 2019-2020 Taxes that are a Lien on Real Property per NCGS §105-369(a)."

- Amend Closed Session to Read: "Recess into Closed Session Pursuant of NCGS §143-318.11(a)(1)(5) for Review and Approval of Closed Session Minutes from the 9/8/20, 10/29/20, 11/10/20, 11/23/20, and 1/12/21 Meetings; and To Discuss Terms of Potential Acquisition of Real Property."

MOTION: Mayor Pro Tem Vandenberg moved to adopt the agenda as amended.

VOTE: The motion passed unanimously.

B. Presentations

TIME STAMP 4:20

1. Bonds Grove Church Road and Waxhaw-Marvin Road Reconfiguration Options and Feedback

Rohit Ammanamanchi, Planning & Zoning Administrator, explained that a study is being conducted on the Bonds Grove Church and Waxhaw-Marvin Road intersection to determine how best to reconfigure the intersection to address traffic and safety concerns. The two options being considered are a traffic light or a roundabout. An online public comment period will start on March 8. Council directed Mr. Ammanamanchi and Mr. Yow to post communications about the public comment period.

TIME STAMP 13:00

2. Marvin Heritage District Next Steps

Mr. Ammanamanchi recapped his presentation on the Marvin Heritage District from the previous week's Council retreat. Based on recent feedback from property owners, he recommended to Council to ask property owners to submit professional sketch plans depicting what their desired and feasible development would be. He added that staff would then consolidate the plans into one final scenario and contract DFI to determine the economic feasibility of that scenario. Council discussed this item in depth.

C. VILLAGE HALL

TIME STAMP 23:00

1. Discussion and Consideration of Village Hall Documents

Christina Amos, Village Manager, briefed Council on the pre-bid meeting that took place with interested vendors on Monday, February 22. She then explained the project manual and answered questions from Council. Council discussed the manual and bid documents in depth. She asked Council to consider creating a subcommittee to recommend finishes for the new Village Hall.

MOTION: Mayor Pro Tem Vandenberg moved to create a Village Hall Design Finishes Subcommittee with herself and Mayor Pollino.

VOTE: The motion passed unanimously.

Ms. Amos also informed Council about a potential drainage issue at the site resulting from the installation of a drainage pipe by NCDOT between the two roundabouts on New Town Rd. She distributed a survey showing the pipe. (See attached survey, which is hereby incorporated as a reference into these minutes). She asked Council to authorize her to have an engineer examine the site to determine what work is needed to resolve the issue. Council agreed and asked Ms. Amos to reach out to state representatives to help recoup costs from NCDOT.

MOTION: Mayor Pro Tem Vandenberg moved to authorize the Manager to work with Dewberry Engineering to assess and work to solve the drainage issues at the Marvin School and New Town Road intersection to mitigate the issues of any future development and authorization to spend \$15,000 with McConnell Grading who is the Village's all-inclusive vendor. **VOTE:** The motion passed unanimously.

D. ITEMS OF DISCUSSION

TIME STAMP 1:02:50

1. Consider Call for Public Hearing to be held at 6:30pm on March 9th, 2021 at Village Hall for Conditional Use Permit (CUP) Application #21-12576: 1000 Spyglass Lane, Pool in a Side Yard

Council asked Mr. Ammanamanchi about the little documentation provided by the pool builder and directed him to not accept further applications with this little documentation going forward.

MOTION: Councilman Wortman moved to call for Public Hearing to be held at 6:30pm on March 9th, 2021 at Village Hall for Conditional Use Permit (CUP) Application #21-12576: 1000 Spyglass Lane, Pool in a Side Yard.

VOTE: The motion passed 3-1. Councilmembers Lein, Marcolese, and Wortman voted "Yea." Mayor Pro Tem Vandenberg voted "No."

MOTION: Mayor Pro Tem Vandenberg moved to take a 1-minute recess.

VOTE: The motion passed unanimously.

MOTION: Mayor Pro Tem Vandenberg moved to reconvene.

VOTE: The motion passed unanimously.

TIME STAMP 1:13:30

2. Consider Call for Public Hearing to be held at 6:30pm on March 9th, 2021 at Village Hall for Zoning Text Amendment Application #21-12592 to Revise the Definition of Rural Subdivision in §150.015 DEFINITIONS

Mr. Ammanamanchi explained that the applicant wished to build a rural subdivision of six lots on 19 acres. The proposal meets all requirements of a rural subdivision, except that the tract is less than the required 25 acres. He explained that the Planning Board recommended changing the requirement to 12 acres. Council discussed this item in depth and directed Mr. Ammanamanchi to change it to 10 acres.

MOTION: Mayor Pro Tem Vandenberg moved to call for Public Hearing to be held at 6:30pm on March 9th, 2021 at Village Hall for Zoning Text Amendment Application #21-12592 to Revise the Definition of Rural Subdivision in §150.015 DEFINITIONS.

VOTE: The motion passed unanimously.

TIME STAMP 1:22:20

3. Discussion and Consideration of Options to Address Flooding on the Marvin Loop Greenway

Derek Durst, Public Facilities Manager, explained that explained that the Village Engineer has recommended raising the actual trail to address flooding issues. Council discussed this item in depth. Councilmember Wortman stated he would visit the site during the weekend to get some grading shots, after which Mr. Durst would use the information gathered to acquire a new quote from McConnell Grading.

TIME STAMP 1:31:00

4. Discussion and Consider Approval of Village of Marvin Sponsorship and Donation Policy

Mr. Durst explained that the draft policy has been reviewed by the Village Attorney. Council discussed this item in depth and asked Mr. Durst questions regarding the terms of the sponsorship. (See attached policy, which is hereby incorporated as a reference into these minutes). Council directed Ms. Amos to determine whether donations to the Village are tax deductible.

MOTION: Mayor Pro Tem Vandenberg moved to approve the Village of Marvin Sponsorship and Donation Policy. **VOTE:** The motion passed unanimously.

TIME STAMP 1:35:10

5. Discuss and Consider Approval of Contract with Spotz for Facility Scheduling Software for an Annual Rate of \$600 and 4% fees Associated with Credit Card Processing

Mr. Durst explained that this company would handle the schedules for rentals of the Barn, Picnic Shelter, and Community Gardens at Marvin Efird Park. He noted that the company cut its rate in half due to the few number of facilities that need rentals to be managed. Council directed Mr. Durst to move forward.

TIME STAMP 1:42:30

6. Discussion of List of Projects for State Representative Assistance

Ms. Amos recapped the previous Council retreat at which Council asked state representatives to aid with projects, including financing and construction of roundabouts; lighting; resurfacing New Town Road; reducing speed limits on New Town, Marvin, and Marvin School Road; stop signs in Wyndham Hall; large pothole at the New Town and Marvin Road intersection; the resurfacing of the Tom Short Road roundabout in Marvin Creek; and the drainage issue at the Village Hall property. Council discussed this item in depth and directed Ms. Amos to email these concerns to the state representatives.

TIME STAMP 1:52:00

7. Discussion and Consideration of Solid Waste and Recycling RFP

Ms. Amos walked through the RFP page-by page asking Council if they had any changes or questions. Council discussed this item in depth and directed Ms. Amos to amend the RFP with their feedback.

MOTION: Mayor Pro Tem Vandenberg moved to take a 5-minute recess for lunch and bio break. **VOTE:** The motion passed unanimously.

Mayor Pollino reconvened the meeting.

TIME STAMP 2:50:20

8. Discuss and Consider Adoption of OR-2021-02-01 to Appropriate Unassigned Fund Balance to Transportation Budget for Local Match Payment to NCDOT for the Construction of a Roundabout at New Town and Marvin Road

Ms. Amos informed the Council that a correction needs to be made to the budget ordinance and consideration needs to be delayed until the March 9 regular meeting. Council agreed to delay consideration. Ms. Amos distributed copies of the Village's agreement with NCDOT about the roundabout, as well as a copy of an NCDOT presentation from the 1/28/21 Council Work Session Meeting. (See attached agreement, which is hereby incorporated as a reference into these minutes). She also informed Council that NCDOT is requesting an additional \$105,000 for the construction of the roundabout at New Town and Marvin Road. Council discussed this in depth and directed Ms. Amos to contact State Representatives about the poor service that NCDOT has provided. Council agreed by consensus to provide additional funding of an undetermined amount at a future date.

TIME STAMP 3:30:20

9. Discuss and Consider Applicants for Appointment to the Planning Board for a Term Commencing 3/1/2021 and Expiring 3/1/2024

Austin W. Yow, Village Clerk & Assistant to the Manager, informed the Council that there were two applicants for the vacant Planning Board seat. Council discussed the applicants and chose to delay consideration until the March 9 regular meeting.

TIME STAMP 3:33:40

10. Discussion of Resolution to Oppose the Aventon Apartment Complex

Mr. Ammanamanchi explained that the draft resolution was to oppose the high-density Aventon Apartment Complex rezoning request. This development if approved would result in the construction of 310 apartments near the intersection of New Town and Providence Road. Council discussed this item and decided that it was prudent to adopt the resolution immediately.



RS-2021-02-01

A RESOLUTION OPPOSING THE AVENTON CONDITIONAL REZONING REQUEST

WHEREAS, the Village of Marvin Council's purpose is to represent the desires of its citizens and to serve as a voice for the greater good of the community and support the same for neighboring municipalities; and

WHEREAS, the Village of Marvin has joined an alliance with four other municipalities in Union County, including Weddington, to collectively oppose high-density development; and

WHEREAS, the Village of Marvin recognizes that the Aventon rezoning has been proposed to Union County in a residential area bordered by both Marvin and the Town of Weddington, and 310 units of high-density (R-4 apartments) residential development on 19.07 acres for a density of 16.2 units per acre; and

WHEREAS, the Village of Marvin recognizes that 98% of Marvin residents are not in favor of apartments in the area according to our 2019 Resident Survey; and

WHEREAS, the Village of Marvin recognizes that high density development puts a burden on the infrastructure and encourages growth that outpaces needed improvements, especially the delayed NC-16 widening project; and

WHEREAS, stormwater issues have been a problem in the area and will be accentuated by this high-density development; and

WHEREAS, traffic in the area is over capacity on Providence Road and New Town Road; these roads cannot sustain additional impact from high density residential development; and

NOW, THEREFORE, BE IT RESOLVED that the Marvin Village Council hereby requests the Union County Board of County Commissioners listen to the desires of the citizens and stay consistent with existing low-density residential County and Village zoning of surrounding parcels and reject the rezoning request for the Aventon apartment complex.

Adopted this 25th day of February 2021.

MOTION: Mayor Pro Tem Vandenberg moved to amend the agenda consideration to approve the resolution to oppose the Aventon Conditional Rezoning Request, RS-2021-02-01.

VOTE: The motion passed unanimously.

MOTION: Mayor Pro Tem Vandenberg moved to approve RS-2021-02-01, the Resolution Opposing the Aventon Rezoning Request.

VOTE: The motion passed unanimously.

TIME STAMP 3:39:25

11. Discussion of Roadway Median Ordinance

Mr. Ammanamanchi explained that he has revised the subjective language of this ordinance pursuant to the direction of Council. Council directed Mr. Ammanamanchi to submit the revised ordinance to the Planning Board for review.

TIME STAMP 3:41:00

12. Discussion of Statement of Economic Interest and Code of Ethics Forms

Mr. Yow updated Council on the receipt of Statement of Economic Interest and Code of Ethics forms from staff and board members. Council directed Mr. Yow to provide another update at the March 25 work session.

TIME STAMP 3:43:20

13. Discussion of Joint Meetings with the Planning and PR&G Boards

Mr. Yow informed Council that based on the feedback from Council and Board Members the best dates to hold joint meetings are Monday, March 8 at 6:30pm for the Planning Board, and Tuesday, March 23 at 9am for the PR&G Board.

TIME STAMP 3:50:20

14. Discussion of Gates and Private Roads Ordinance

Mr. Ammanamanchi explained that recently certain subdivisions have informed staff that they wish to install gates at the entrances to their subdivisions. Currently, the Village does not allow for the creation of new private roads or the installation of gates on public roads. Mayor Pro Tem Vandenberg added that the Village's sign ordinance was amended in 2017 to allow the installation of gates for rural subdivisions. Mr. Ammanamanchi highlighted that these ordinances are contradictory and asked Council how they wished to address the issue of gates. Council discussed this item in depth.

Council agreed that Mr. Ammanamanchi and the Village Attorney should identify where and how the ordinance needs to be clarified. Council will discuss this item again at the March 25 work session.

TIME STAMP 4:18:10

15. Review of Council Meeting Minutes from 1/28/21, 2/3/21, and 2/9/21

Council reviewed the minutes from 1/28/21, 2/3/21, and 2/9/21 and made no changes.

MOTION: Mayor Pro Tem Vandenberg moved to approve the minutes from 1/28/21, 2/3/21, and 2/9/21. The minutes will be on the consent agenda for the March 9 regular meeting.

VOTE: The motion passed unanimously.

TIME STAMP 4:20:00

16. Discussion of Spring Town Hall Ideas and "Marvin Day" Ideas

Council discussed idea and topics to be incorporated into the agenda for the Spring Town Hall Meeting to be held on Wednesday, May 12 at 6:30pm at Forest Hill Church in Waxhaw. Council also discussed creating a "Marvin Day" to celebrate with the community beginning in 2022. Council discussed event planning and potentially creating committee to begin preparations. Staff will bring this item back at the March 25 work session.

17. Discussion of Candidate Questionnaire

Council discussed dedicating a page on the Village's website to house information about candidates running for the Village Council. If approved, this would take the form a questionnaire where candidates could provide some basic information about their qualifications and why they are running for office.

Mayor Pollino informed Council that he spoke to a resident of Innisbrook regarding an easement provide access to the Preserve Trail. He added that this resident asked about how long it would take to build the connection to the trail if he agreed. A meeting is scheduled with this resident and members of the Village staff about this proposed easement.

F. COMMUNICATIONS

TIME STAMP 4:58:00

1. Discussion and Consideration of Communication Topics for March 2021

Mr. Yow presented the list of proposed communications for March. He also asked for feedback regarding publishing additional information about the Inherit the Land Documentary, participating in a local magazine, and topics for an upcoming projects newsletter. Council decided to not circulate further information about the Inherit the Land Documentary and to contribute to the local magazine, staff availability permitting. Council discussed topics for the upcoming projects newsletter.

2. Additional Council Seat

Council discussed whether they were interested in pursuing adding another Council seat that would be filled by election in 2023. Council will discuss this idea in greater detail at the March 9 regular meeting.

G. REPORTS AND UPDATES

TIME STAMP 5:31:15

1. Manager's Report

a. Tom Short Sidewalk Update

Ms. Amos informed Council that the Village Attorney has determined based on precedent that absent any agreement that the Village is responsible for the maintenance of the Tom Short sidewalk repairs. Council directed Ms. Amos to add this topic to the list of projects for assistance from state representatives.

b. Street Blade Posts & Speed Limit Signs Update

Ms. Amos stated that the street blades for Weddington Chase and Canterfield Creek are not compatible with their current brackets/posts. She presented quotes for replacing the posts/brackets and asked Council if they wished to standardize brackets going forward. She also distributed photos of the proposed posts/brackets and copies of emails with the subdivision HOAs showing that they approve of the posts/brackets. (See attached documents, which is hereby incorporated as a reference into these minutes). Council agreed to proceed with addressing the posts/brackets in the two subdivisions. Council also chose to provide subdivisions with the option of either having the standardized bracket or paying the cost difference to upgrade to a different design. This upgrade option would also extend to the installation of speed limit signs. Staff will prepare a budget amendment to cover the cost of standardizing brackets in Weddington Chase and Canterfield Creek.

MOTION: Mayor Pro Tem Vandenberg moved to purchase standardized brackets with PBH-9 as shown for Canterfield Creek and Weddington Chase.

VOTE: The motion passed unanimously.

MOTION: Mayor Pro Tem Vandenberg moved to authorize a future budget amendment to appropriate funding of \$11,000 from fund balance reserve "sign" to pay for brackets.

VOTE: The motion passed unanimously.

MOTION: Mayor Pro Tem Vandenberg moved to amend the spec manual to include posts/brackets as approved by new policy.

VOTE: The motion passed unanimously.

MOTION: Mayor Pro Tem Vandenberg moved make a signpost/bracket upgrade policy.

VOTE: The motion passed unanimously.

c. Update from Retreat (Discussed prior to "a. Tom Short Sidewalk Update")

Ms. Amos shared a presentation from the Union County Sheriff's Office on response times, which showed Marvin had a much faster response time than unincorporated Union County. (See attached presentation, which is hereby incorporated as a reference into these minutes).

d. Community Clean Up Day

Ms. Amos informed Council that a resident called and wishes to organize a Community Clean Up event. She asked Council for their consent to advertise this event. Council agreed and directed staff to place this item on the next PR&G Board meeting agenda.

e. Crash Data for Roundabout

Ms. Amos distributed crash data for the Marvin and New Town Road intersection which Council previously requested. (See attached documents, which is hereby incorporated as a reference into these minutes).

TIME STAMP 6:02:40

2. Planner's Report

a. CRTPO Resources Update

Mr. Ammanamanchi stated that CRTPO would issue staff to help the Village coordinate with NCDOT, USDOT, and to tabulate the right of way required from property owners to proceed with the expansion of the Marvin Loop Trail.

b. Roundabout Lighting Update

Mr. Ammanamanchi informed Council that Union Power sent the survey data to NCDOT, which should move the process forward for getting lighting installed at the two existing roundabouts on New Town Road.

c. Union County Happenings

Mr. Ammanamanchi informed Council that the Union County Planning Board will review the Aventon Rezoning Request on March 2 and that the public must either give comments in-person or submit them by email. At the same meeting, the Board will have their first look at the Union County 2050 Comprehensive Plan. A vote from the County Planning Board on the plan is expected in April. They are also considering a policy to prohibit upward zoning of properties along corridors that needs transportation infrastructure upgrades. He concluded by briefly covering the timeline of adoption for the 2050 Comprehensive Plan, which is currently slated for June.

d. Barcroft Residency Issue

Mr. Ammanamanchi informed Council that the developer of Barcroft did an occupancy check and that he expects to hear back soon.



Village of Marvin Sponsorship and Naming Policy

I. INTRODUCTION AND PURPOSE

In 2012, the Village of Marvin opened its first public facility, Marvin Efird Park. The Village Council understands the need to supplement its current and future projects both at the park, and throughout the Village through relationships with businesses, individuals, and organizations by means of sponsorships, grants and donations. For the purpose of project funding, the Village seeks to create mutually beneficial relationships that will allow the Village to offer its citizens amenities, programs, facilities or structures through alternative sources that will allow us to accelerate our ability to provide these enhancements to the community. The purpose of this sponsorship program is to generate additional revenues for the Village and it is not intended to provide a public forum for communication and debate. The Village will operate its sponsorship program in a manner that maximizes revenue, while ensuring that the sponsorship materials displayed do not negatively affect the goodwill of citizens and visitors and do not diminish the reputation of the Village.

In addition to procuring this funding, the Village will work with its citizens to give back to the community by honoring its people, businesses, or organizations by means of recognition of amenities, facilities, or structures as outlined in the following naming policy. The Village reserves all rights for approving acceptable sponsorships and names for public amenities, facilities or structures located on Village property. All sponsorship and naming requests must be consistent with our Village mission.

II. POLICY

- 1. Sponsorships vs. Donations
 - A. The Village of Marvin recognizes that sponsorships are made when there is an expectation of a specific benefit in return. This benefit may be, but is not limited to, recognition in the form of advertising in newsletters, plaques, at Village events or naming rights. Sponsorships can be in the forms of services, funds, or in-kind gifts.
 - B. Donations can be made to the Village in the form of services, funds, or gifts-in-kind, however there is no expectation or recognition or compensation, or restrictions on how this money or gift is to be used within the Village. Since donations can be used at the discretion of the Council, there is no policy for donations. Donors, however, may be recognized in accordance with the sponsorship guidelines and this decision is at the discretion of the Council.
- 2. Sponsorships and Names must be in accordance with the following Sponsorship and Naming Guidelines.

- 3. Sponsorship and Naming agreements must be confirmed in writing via the Sponsorship/Naming Application before being accepted by the Village.
- 4. Sponsorships and Names must be consistent with the mission of the Village of Marvin.
- 5. Sponsorships or Names will not be accepted if they were to cause the Village any loss of authority or are not consistent with the Sponsorship/Naming Guidelines.
- 6. The Village has the right to limit the number of facilities, structures, or sites to which Sponsorships and Naming Rights can be applied.
- 7. The Village will not accept cash as a form of payment. Payment should be by check, wire/ credit card, or other "traceable" method. The Village makes no representation as to whether any funds collected may be claimed as a tax deduction and any person making a contribution is advised to seek the advice of a tax professional as to the deductibility of their contribution.
- 8. This program does not create a public forum. The Village reserves the right to exercise full editorial control over the denial, location, method, size, appearance and wording of any sponsorship messages.

III. SPONSORSHIP / NAMING GUIDELINES AND CRITERIA

- 1. Businesses, individuals, and organizations are eligible for *Sponsorships* if they meet the following applicable criteria:
 - A. Supports the Village's mission.
 - B. Promotes positive and healthy images and messages in our community.
 - C. Provides sponsorships for the purpose of improving or enhancing the lives of the Village citizens.
 - D. Preserves cultural and historical features of our Village.
 - E. Sponsorships will relate to the intent of the Village owned property.
 - F. Sponsorship or Naming shall not create any right to use the Village name, logo, slogans or other graphic representations in any messages without the prior written consent of the Village.
- 2. Businesses, individuals, and organizations are eligible to request *Naming Rights* in limited and unusual circumstances which generally involve substantial contributions. Naming Rights must be approved by Village Council.
- 3. Sponsorships and Naming Rights are maintained as a nonpublic forum. Although the Village recognizes and confirms that entering into a sponsorship agreement is not an endorsement of that sponsor or its goods or services, sponsorships do imply some affiliation between the sponsor and the Village. Such perceived affiliation can affect the public trust and the Village's ability to govern equitably, efficiently and effectively. Therefore, no potential sponsor and no offer of sponsorship will be approved that might compromise the public trust or the public's perception of the Village's ability to act in the public interest or that the Village deems might have a negative impact on its mission, image or values. The Village also intends to preserve its right and discretion to exercise full editorial control over the placement, content, appearance and wording of all sponsorship

recognition messages. The Village may make distinctions on the appropriateness of the sponsors recognition message but not the potential sponsor's viewpoint.

Sponsorships or Naming Rights will *not* be considered if:

- A. They involve illegal activity or that promote drugs, alcohol or tobacco.
- B. A company's primary revenue is derived from the sale of alcohol, tobacco, firearms, or are regarded as an "adult" business or if they contain messages for products, services or entertainment directed to sexual stimulation.
- C. They come from religious or political organizations.
- D. They contain messages for products or services related to human reproduction or sexuality, including but not limited to contraceptive products or services, other products or services related to sexual hygiene, counseling with regard to pregnancy, abortion or other sexual matters.
- E. They give the appearance that a product or service is endorsed by the Village of Marvin or if their sponsorship would create a conflict of interest or policy with the Village.
- F. The messages include language, pictures, or other graphic representations that are unsuitable for exposure to persons of young age and immature judgment, or shall be derogatory of any person or group because of race, national origin, ethnic background, religion or gender.
- G. The message may adversely impact the mission, image and values and goals of the Village.
- 4. The Village may take into consideration the following factors before deciding to enter into a sponsorship agreement. The outcome of these considerations may be cause for a sponsorship not to be accepted:
 - A. The timeliness or readiness of the individual, company, or organization to enter into a sponsorship agreement.
 - B. Any operating or maintenance costs associated with the sponsorship agreement.
 - C. The sponsorship is reasonably related to the project or purpose for which it is being given, and;
 - D. If the sponsorship will help generate more revenue and/or less cost to the Village than without it.
 - E. The extent and prominence of the sponsorship recognition, including aesthetic characteristics of the public display of sponsorship.

IV. APPLICATION AND SELECTION PROCESS

- 1. The Village Council is the governing body that may (i) approve a list of predetermined sponsorship opportunities, (ii) approve sponsorships of \$10,000 or more and (iii) approve all Naming Rights.
- 2. The Village Manager or designee may approve any sponsorship in amounts less than \$10,000.

V. SPONSORSHIP AND NAMING RIGHTS LEVELS AND BENEFITS

The goal of the Village of Marvin is to yield similar benefit values for the various types of sponsorships. New sponsorship opportunities may be added to the current list of opportunities at any time. Likewise, some sponsorship opportunities are limited and once the maximum number of opportunities is met, these options may no longer be available. Where partial sponsorships are available, there may be no more than two sponsors of one facility/amenity/structure/ program.

A. Facility/Structure Sponsor

A sponsorship agreement that includes a payment to the Village for the purpose or constructing, renovating, or purchasing a specific facility or structure.

Benefits Include:

- Plaque Recognition on Village property.
- Other possible negotiated benefits as agreed to on the sponsorship agreement application.

B. Amenity Sponsor

A sponsorship agreement that includes a payment to the Village for the entire (100%) cost of a specific amenity.

- Plaque/Signage Recognition on Village property and sponsored amenity.
- Other possible negotiated benefits as agreed to on the sponsorship agreement application.
- Specific Amenity Projects may have pre-determined sponsorship structure/ levels as approved by the Village.

C. Event/Program Sponsor

A sponsorship agreement that includes a payment to the Village, in part, to be applied to the overall operating expenses of a specific event or program to be used as the committee, organizers, or Council decides.

- Recognition on all event/program advertisements (media and promotional materials) for the specific sponsored event.
- Recognition at the event/program as Event/Program sponsor.
- Other possible negotiated benefits as agreed to on the sponsorship agreement application.

Naming Rights may be granted for facilities/structures or sites as predetermined as applicable by the Village Council and where the Naming Rights criteria has been met.

THIS AGREEMENT is made and entered into on the last date executed below, by and between the North Carolina Department of Transportation, an agency of the State of North Carolina, hereinafter referred to as the "Department", and the Village of Marvin, hereinafter referred to as the "Municipality."

WITNESSETH:

WHEREAS, the Department and the Municipality on 3/12/2018, entered into a certain Project Agreement for the original scope: the conversion of the existing stop-controlled intersection at New Town Road (SR 1315) and Marvin Road (SR 1312) to a roundabout, programmed under Project U-6088; and

WHEREAS, the Department and the Municipality on 4/22/2020, entered into a Supplemental Agreement to return the Municipality's local participation in the construction phase of the project due to the delay in the letting date of the project; and

WHERAS, this Supplemental Agreement is to address the increase in project costs and revise the local participation in the ROW and CON phases of the project.

NOW THEREFORE, the parties wish to supplement the aforementioned Agreement whereby the following provisions are amended:

7. FUNDING

The new estimated cost of the project is \$1,905,000 as shown in the *revised funding table* below. Costs that exceed the total estimated cost will be shared equally between the Department (50%) and the Municipality (50%) to all phases of the project.

- A. The estimated local match for the Right of Way (ROW) phase is \$120,000 of which \$15,000 has previously been received by the Department. Upon partial execution of the Agreement, the Municipality shall submit a check for \$105,000 to the Department's Division Engineer to cover the remainder of the local match for the ROW phase.
- B. The estimated local match for the Construction (CON) phase is \$100,000. Prior to the Department requesting authorization for Construction, the Department will request a check from the Municipality in the amount of \$100,000 to cover the local match of the construction phase.
- C. Upon completion of the Project, the Department will calculate the actual costs of the work and will bill the Municipality for any excess project costs based on the above participation rates. Reimbursement to the Department shall be made in one final payment within sixty days of invoicing by the Department. A late payment penalty and interest shall be charged on any unpaid balance due in accordance with NCGS § 147-86.23.

OTHER PROVISIONS

The other party to this Agreement shall comply with Title VI of the Civil Rights Act of 1964 (Title 49 CFR, Subtitle A, Part 21) and related nondiscrimination authorities. Title VI and related authorities

prohibit discrimination on the basis of race, color, national origin, disability, gender, and age in all programs or activities of any recipient of Federal assistance.

A copy or facsimile copy of the signature of any party shall be deemed an original with each fully executed copy of the Agreement as binding as an original, and the parties agree that this Agreement can be executed in counterparts, as duplicate originals, with facsimile signatures sufficient to evidence an agreement to be bound by the terms of the Agreement.

Except as hereinabove provided, the Agreement heretofore executed by the Department and the Municipality on 3/12/2018 and 4/22/2020 are ratified and affirmed as therein provided.
